#### **ABOUT THIS MANUAL**

This manual will provide the operator with important information about installing and maintaining the Gold Line® VN-1 Changer. General information is provided for the hopper, stacker, and controller. However, if additional information is needed for these components, please refer to the appropriate manual. To obtain assistance from the manufacturer, please call (800) 837-5561 or (419) 867-4858.

When calling for assistance, it is important to have serial numbers readily available. Please take the time to record this information in the spaces provided.

#### <u>I. INSTALLATION</u>

#### MOUNTING

Cabinets are pre-drilled for wall mounting or mounting on an optional base. Bases are pre-drilled for securing to the floor. Do not use leveling screws when fastening to the floor. Changers mounted on bases should be securely fastened to both the floor and the wall. Fasteners to be used should be recommended by your engineer as to strength and suitability for floor and wall composition. Hamilton will not be responsible for injury due to improper installation.

For mounting in wall, cabinet size is 36-3/8" H x 9-15/16" W x 13-1/4" D.

#### ELECTRICAL

This currency changer is operated on 120VAC, 60Hz. This changer uses a 5 AMP circuit breaker. Unit may be hard-wired with conduit if desired.



NOTE: A GROUND FAULT INTERRUPTER IS REQUIRED. The recommended Ground Fault Interrupter should have the following specifications:

- 120VAC
- 15 AMP
- 6-10mA trip level
- Should not trip when power is removed from circuit.

Attached to the main harness is a 1-pin white Molex connected to a white wire. There should be a bright vellow tag attached to this wire with the following warning:

> WARNING: For security reasons, this plug should remain disconnected until such time as you need to utilize the hopper's manual run switch.

There is no need to connect this plug for normal operation. If for some reason you wish to utilize the manual run switch, be sure to unplug the Molex afterward.

#### <u>II. MAINTENANCE</u>



**CAUTION!** Do not use oil, grease, or solvents on any part of this changer except as clearly specified in this manual, the hopper manual, the validator manual, or the stacker manual.

#### **HOPPER**

Any lubrication in the hopper can result in a faulty payout. To clean the hopper monthly, empty coins and vacuum. Use a soft brush to loosen dirt. Refer to the hopper manual for details on maintenance. (Hamilton HSH Hopper manual document #101-0010.)

#### **VALIDATOR**

Refer to the appropriate validator manual for lubrication, maintenance instructions and all other information. THE HAMILTON STA AND XE VALIDATORS SHOULD BE SERVICED ANNUALLY TO MAINTAIN MAXIMUM PERFORMANCE. THIS WORK SHOULD ONLY BE DONE BY A TRAINED TECHNICIAN. (Hamilton STA Validator manual document #101-0011 and Hamilton XE Validator manual document #101-0079.)

#### STACKER

Refer to the stacker manual for maintenance instructions. (Hamilton Single Stacker manual document #101-0008 and Hamilton Dual Stacker manual document #101-0006.)

#### **CONTROLLER**

The microprocessor based Hamilton C2000 Controller monitors the systems of the VN-1 Bill Changer. If a problem is detected, the controller will shut down and display the appropriate error code. Refer to the C2000 Operation Manual for error codes. (C2000 Operation Manual document #101-0009.)

The twelve DIP switches located near the computer-reset button determine the payback of coins on multi-hopper change units. There is no need to change the switch settings on a typical model VN-1 Changer, as they are set to the payout arranged at the time of order. However, if the need arises, the C2000 Operation Manual does offer alternative switch settings. If none of these settings are suitable to your needs, contact Hamilton Mfg. for assistance. YOU MUST HAVE THE CONTROLLER MODEL NUMBER READY WHEN CALLING.

Another option for this machine is the Audit Pro 2000 Controller which allows owners to program specific payouts and also to view audit information. The Audit Pro 2000 Hand-held was designed to be able to be carried to multiple machines or back and forth from the office. THE HAND-HELD IS TEMPERATURE SENSITIVE, DO NOT LEAVE IT IN THE MACHINE. For other information, refer to the Audit Pro 2000 Manual, document #101-0048.







#### Internal Parts Diagram




